Admission Policy

(International)

Maranatha Christian Academy was established in 1985 to provide Christian education for the Windsor area community. The program is designed to present each subject from a Christian perspective, to a variety of student abilities.

We are committed to the provision of an enriched and challenging program for every student. Students are expected to enter the school with a learning readiness. They are required to actively participate in the classroom, working diligently on assignments, asking for help when necessary, and showing respect for one another and God in all situations.

To protect this vision and mission for Christian education, the Board of Maranatha Christian Academy has adopted the following admission criteria:

- a) The parents or legal guardians in their country of origin of the student (here to referred to as “parent or legal guardian”) are required to be active members of a Christian church that declares Jesus Christ as Lord and Saviour.
- b) The parent or legal guardian agrees to the school’s Statement of Beliefs.
- c) The parents or legal guardians acknowledge the Bible to be the authoritative Word of God that provides divine direction for all of life.
- d) A Christian host family must be available for the student.
- e) The parents or legal guardian and the student agree that the student will participate in all compulsory courses and school activities.
- f) The student agrees to endorse the Memorandum of Understanding.

The Board reserves the right to deny, admit or cancel admission due to any of the following criteria:

- a) Insufficient classroom space
- b) Inability to serve specific learning needs
- c) Behaviour contrary to school policy
- d) Admission criteria are not met
- e) Any other reason that the Board may deem in the best interest of Maranatha Christian Academy.

Admission Process

(International)

Follow the following steps to enrol a student in Maranatha Christian Academy

- Submit completed "Admission Application"
- Submit copies of the last two academic reports from present school (translated into English)
- Submit photocopy of passport including photo
- Submit completed "Tuition Agreement" form
- Submit proof of immunization translated into English
- Submit completed "Memorandum of Understanding"
- Submit signed pastoral reference form
- Submit signed Maranatha Christian Academy Statement of Beliefs (International)
- Submit non-refundable **application fee**.
- Principal approves admission
- Letter confirming acceptance is sent to the family

Upon acceptance from school and receiving valid study permit issued by Canadian Immigration

- Submit tuition deposit upon registration

Upon arrival into the country:

- Upon arrival, the student and guardians(s) meet with the Principal
- Submit tuition payment
- Submit valid study permit issued by Canadian Immigration
- Submit proof of health coverage
- Custodianship Declaration for children not living with parents.

Statement of Beliefs

(International)

The following statements are part of our Core Family Values that reflect the beliefs of our school board members, administration, and staff based upon the teaching of the Bible, Old and New Testaments, and the school will teach these values to our students. Our school will not allow the teaching of hatred against any group or individual.

GOD: We believe in an eternal God who is the creator and sustainer of the Universe. God is presented in the Bible as a Triune God, Father, Son and Holy Spirit, existing in three distinct Persons, one in essence, unity, purpose and action. God has been manifested in flesh in the Person of His Son, the Lord Jesus Christ, who is fully God and fully man.

CHRIST: We believe Christ is, and ever was the eternal Son of God, co-equal in Godhead with the Father and the Holy Spirit. In Him we have the final and complete revelation of God. Christ came to this world born of the Virgin Mary, and conceived by the Holy Spirit. We believe in Christ's sinless humanity, his miracles, his substitutionary death and his bodily resurrection. Christ ascended to heaven and will come again to take the believers to be with Him forever as He has promised.

BIBLE: We believe the Bible, consisting of sixty-six books in the old and new testaments, is the only written word of God. The Bible is inspired by God and is infallible. We believe that the absolute authority of the Bible is a primary and vital tenet of the Christian faith. The Bible embodies all the truth of God revealed to man. The Bible, by the power of the Holy Spirit, enlightens our understanding of God, of ourselves and of creation. The Bible is the only written authority by which God directs and governs the lives and activities of all true Christians including the education of their children.

CREATION: We believe the world was created by God in six days as described in Genesis 1, and it is maintained by God's providence. The world, in its origin, its preservation, and its ultimate restoration, is the work of God. Man was created in the image of God to glorify his name and to enjoy fellowship with the Creator. Therefore, we can understand the world rightly only in its relation to Him.

SIN: We believe sin is disobedience to God. People by sinning, separated themselves from God, and brought God's curse upon creation. The wages of sin is death. All people are born sinners by nature and deeds and are in need of the redemptive work of Christ.

CHRISTIANS: We believe Christians are those who believe in the Lord Jesus Christ as their personal Saviour and have repented of their sin and have accepted, by faith, the sacrifice of Christ on the cross as the only means for their eternal salvation. Christians commit their lives to the Lordship of Christ and strive to glorify God, serve Him, and spread His Word in all their endeavours by the power of the Holy Spirit.

SALVATION: We believe by sovereign Grace we have complete and eternal salvation through repentance toward God and faith in the Person and finished work on the cross of our Lord Jesus Christ, who died for our sins, was buried and raised again for our justification.

MARRIAGE: We believe marriage is instituted and ordained by God as a sacred union exclusively for one man and one woman. Sexual intimacy is a gift of God and has its proper place only within the context of marriage with one man and one woman.
